

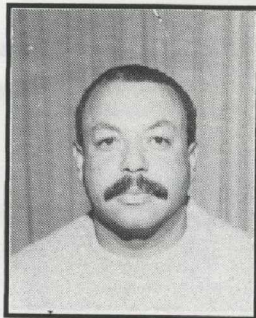

BEGIN WITH THE END IN MIND..

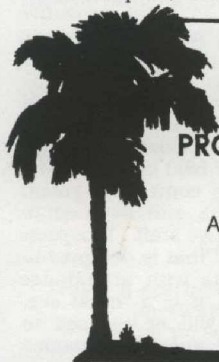
I'm going to encourage you to start each day knowing that you will be productive.

Looking forward to seeing you all at the State Spring Conference in Palm Springs. I'm ready to network, rub elbows, compare, and most of all, *have some fun !!*



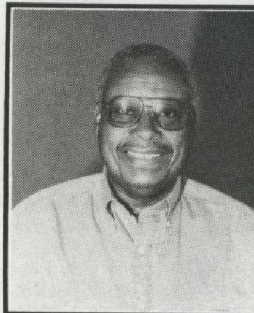

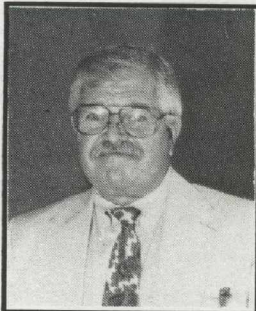

Los Angeles Unified School District has been featured in the news recently concerning their zero tolerance policy. Jim Burcio, CWA, Antioch Unified School District, reports that the Contra Costa County Office of Education has also developed resolutions and policies to support a zero tolerance agreement. When weapons are found on a school campus, meaningful discipline occurs. If a firearm is brought to school, that student does time in a detention facility. In the past, students were cited and released to their parents for firearm violations. Now, there is an immediate response from police and the Juvenile Justice System. When a student is arrested and delivered to juvenile hall, the Juvenile Justice System meets with the parents to determine the next course of action. This proactive stance is a response to the federal mandate for zero tolerance which was part of the Improving America's Schools Act of 1994.

Antioch Unified School District is in the process of implementing several innovative programs. Bay Section members were introduced to one educational setting last Friday at Prospects High School. We held our executive board meeting in a very comfortable conference room, enjoyed lunch in a quiet dining area and listened to presentations given by the administrative staff. Prospects High School is a state of the art facility that is designed to meet the academic needs of students with attendance problems. If you visit the Bay Area, it is a "must see. I'm sure Stan Gittings, Principal, will be pleased to provide you with a grand tour and answer questions concerning this unique alternative education center.

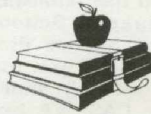

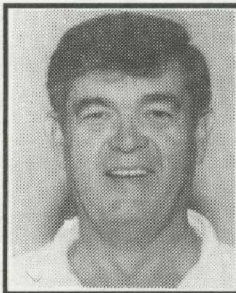
RON GARRISON IS HONORED BY CASCWA AT FALL CONFERENCE

The California Alliance of Pupil Service organizations (CAPSO) is a coalition of state professional organizations represented by pupil service administrators, school counselors, school nurses, school psychologists, school social workers, and supervisors of child welfare and attendance (C-ASCWA). The mission of CAPSO is to work positively and aggressively to bridge the gap between families and schools and to address any barriers to integrated and coordinated support for all students in California's schools.

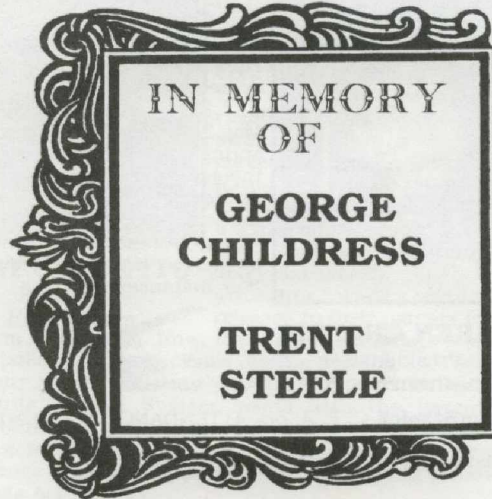
The Association meets three times a year with representatives from the California Department of Education and the Commission on Teacher Credentialing. As a partnership, the Association is working on two goals for 1994-95:

* CAPSO and the California Department of Education will establish full-time representation for student support services including pupil personnel and Health Services Credentials.

* CAPSO will ensure compliance with SB 435 by eliminating employees who do not hold the appropriate Pupil Personnel or Health Services Credentials.

The Association has published two position papers entitled, "School-linked, School-based, Integrated Services," and "Pupil Service Professionals and non-Credentialed Personnel." 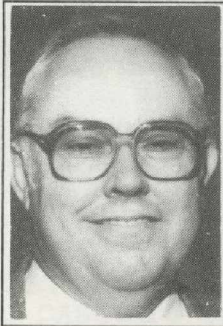

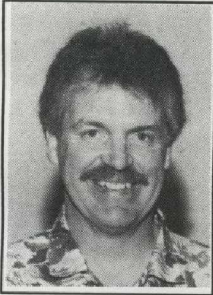

Contract with America's Children

Twenty years ago I worked as a Probation Officer in one of Alameda County's camps for serious offenders. A Sunday service was offered to the words by a Jesuit brother, Jack Ryan. Brother Jack also volunteered many week day evenings and as a result we shared histories and philosophies.

Brother Jack did a tour of duty on a small island somewhere in the South Pacific. This island was co-habitated by the United States military and island natives. According to Jack, the American military offered to buy the small island and make each of the premodern indigenous natives wealthy. The islanders refused the offer saying the island belonged to their posterity. According to Jack, a culture can be judged by its commitment to its children and any culture which failed to put children first was imperil.

I think of Jack whenever I see the work of **Children Now** who's mission it is to keep the condition of California's children in the public eye and to advocate for children's causes. Their report cards and other reports do not support the notion that we as a state and culture value children first.

Children Now has endorsed the "Contract with America's Children" and they encourage us to do the same. They agree with Brother Jack when they write "An enlightened society invests in future generations. Children cannot protect their place in tomorrow's America, but adults can and must create a child - friendly society. That's why we - as organizations, professionals and concerned citizens- have endorsed this contract with America's Children. Join us in urging your friends and neighbors to sign on. Help us send this important message to our policy makers, both Republicans and Democrats, so they can sign on, too. Let these principles start an open and honest discussion of how we can best meet the needs of our children.

These are the Promises We Make to America's Children:

1. **Children First.** We promise to consider children's needs and well-being first and foremost, in evaluating health and welfare reforms, or any other national policy.
2. **Healthy Children.** We promise to ensure that all children get the basics they need to grow up healthy.
3. **Capable Children.** We promise all children a chance to achieve and to realize their potential as productive adults and we expect parents to join in this promise by becoming active partners in their child's education.

7. **Fair Chance.** We promise to support a family's efforts to get ahead by making sure that continuing education and job training are available to people of all means.
8. **Value Youth.** We promise to provide young people with places to go and things to do that will help them become responsible members of our society.
9. **Community Responsibility.** We promise to do our part in our communities to support all children's health development.
10. **Leadership Accountability.** We promise to hold our elected leaders accountable for their responsibilities to safeguard the future of America's children.
