

# SOUTHERN SECTION PRESENTS LEGAL FORUMS AND PLANS FOR PALM SPRINGS CONFERENCE

For CASWCA Southern Section, this has been a banner year. Membership continues to increase and so does the participation of our members at CASCWA approved events. As most of you know, in

November of 1995, Southern Section began sponsoring a series of "Legal Forums" designed to address education specific topics while featuring prominent school-law attorneys. We plan to carry this theme into the 1996/97 CASCWA Spring Conference that Southern Section will host beginning April 30, 1997, at the Marquis Resorts Hotel in Palm Springs.

picked up some new supporters from the San Diego area. On December 6th, we concluded our series of Legal Forums for this school year with a presentation on "School Uniforms." This most outstanding program included "real-live" kids who participated in a fashion show narrated by Frank Boehler. AB 692 Kuehl Chapter 915 Expulsion - Sexual Assault

This bill mandates the expulsion of a

pupil found to have committed or attempted to commit specified acts of sexual assault at school or at a school activity and/or harasses a pupil who is a witness in a school disciplinary proceeding

AB 1012 Machado Chapter 689

Crimes Against Pupils: Sentencing
This bill provides that when a person is convicted of a specified felony sex offense, and that felony was committed within a safe school zone against a victim who was a pupil currently attending school, this fact shall be considered in aggravation in imposing a prison term.

AB 1489 Hawkins/Gallegos Chapter 15 Pupil Expulsion

This law - an urgency statute - requires the one year expulsion for firearms at school or at a school activity as listed in AB 922 (Chapter 974, Statutes of 1995) to be effective immediately as of March 18, 1996.

AB 1721 Ducheny Chapter 879

Student & Consumer Records

This bill provides that information concerning a pupil be furnished in compliance with a court order or lawfully issued subpoena upon the condition that the school district makes a reasonable effort to notify the parent or legal guardian and the pupil.

AB 2295 Sweeney Chapter 600 Graffiti

In any Jurisdiction that has a graffiti abatement program, this bill authorizes the court to order the minor and parent or guardian to keep the damage property or another property graffiti free for a specified period of time and to also undergo counseling. The suspension of driving privilege superseded by AB 2331 - Chapter 918.

AB 2331 Goldsmith

Chapter 918

Crime: Graffiti

This bill requires the court to suspend or delay for one year the driving privileges of a person convicted of graffiti violation, except when person or family hardship exists. This suspension to be reduced by performing community service work under the supervision of the Probation Department.

AB 2433 Harvey Chapter 847 Graffiti - Freeways

This bill sets new fines & community service for graffiti done on or to government facilities or vehicles & fines or imprisonment for graffiti to freeways.

Baca Chapter 343

Disclosure of Pupil Records This bill authorizes school districts or

county offices of education to participate in an interagency data information system that permits access to a computerized data base system within and between governmental agencies or districts.

ÅB 2720 Sweeney Chapter 1052 Expulsion - Adult Assault & Community Day Schools

This bill adds assault or battery upon any school employee as a recommendation for expulsion. If governing board has established a community day school on the same site as a comprehensive school, and the county superintendent of schools certifies that an alternative program of study is not available at a site away from a comprehensive site and the only option for placement of an expelled pupil is at another comprehensive site, that placement may be made.

AB 2834 Friedman Chapter 937 Expulsion Alternative Placement/Community Day School

This bill prohibits a community day school replaced on a comprehensive or continuation school site unless no satisfactory alternative facility is available. It also changes the guidelines for being able to offer Independent Study to expelled students. Effective September 26, 1996.

AB 3077 Baldwin Chapter 891

Community School Apportionments
This bill deletes a provision in existing law which denies community school apportionment to be claimed for pupil enrolled in grades R-6, and limits apportionments for students who have been expelled from a school district, and for pupils in grades 7 through 12 and redefines how the district of residence pays a the county.

AB 3365 Campbell Chapter 561 Gang Violence Suppression

This bill adds public parks and recreation, public libraries and community service departments to the definition of a "community-based'. organization for purposes of the Gang Violence Suppression Program. Community-based organizations shall receive preference over public agencies in any future funding awards.

AB 3492 Frusetta Chapter 200 School Safety

This bill renames the Conflict Resolution and School Violence Reduction Program to the School Resolution Reduction Program which will provide grants to schools and school districts. This bill establishes a demonstration program to be cited as the Targeted Truancy and Public Safety Grant Program. The bill will permit school districts and county offices of education to apply for 3-year grants in a total amount not to exceed \$1,250,000, and will require at least matching funds that could be in-kind resources.

SB 210 Solis Chapter 208 Special Education

Existing law requires each school district, special education local plan area, or county office of education to ensure that a specified continuum of program options is available to meet the needs of individuals with exceptional needs. This bill adds to that continuum of options regular education programs consistent with federal law.

SB 292 Costa Chapter 298 School Attendance

This bill revises how ADA is computed for those pupils who are also enrolled in classes at an University or Community College.

SB 691 Haydon Chapter 17 Employee Assault Notification

This law will increase the fine to not more than \$1000 for failure to report to appropriate law enforcement authorities incidents in which an employee has been assaulted, menaced, attacked, or had physical threats done to them.

SB 1777 O'Connell Chapter 163 Education - Class Size Reduction

This bill creates the Class Size Reduction Program to provide funding to school districts to reduce class size in K and grades 1-3, inclusive, to no more than twenty pupils per certificated teacher.

SB 1938 Mountjoy Chapter 599 Notification Violent Offenses

This bill adds specified sex offenses that a minor has been found to have committed to the

list that the court must give written notice to the superintendent the school district of attendance.

SB 1985 Dills Chapter 485 School Crimes Report

This bill includes each county sheriff as a recipient of the county's school district crime report

alliances and organizations to promote our issues.

- 3) Promote the formation of a Pupil Service Consultant

position in the Department of Education.

In other business, Barbara Bradstock represented us as CAPSO's delegate to the Children's Policy Summit. Invitations to join CAPSO were sent ACSA and CSBA. ACSA was previously a member but has not participated for several years. ~

Stu Greenfield, Assistant Superintendent/ High Schools, was our guest at this meeting. He outlined the diverse responsibilities of his unit and described the state department's funding problems. He described his vision for an "Educational Policy Team," which would be modeled after fiscal policy teams he developed previously, identifying common languages, values, creating a strategic plan and setting standards. This team should definitely include support services.

Stu's assistant, Maria Trejo, encouraged us to demonstrate benefit of support services to educational program. We need to show outcomes to get funding. She emphasized the importance of the "Challenge Agenda" to the Superintendent.

There will be a Health Framework Conference, "Healthy Schools, Healthy People III," in January 16-17, 1997 in Sacramento. CAPSO has been asked to present a panel workshop on Assessing and Managing Child and Adolescent Mental Health Problems. CASCWA will be represented on this panel.

All CAPSO organizations were members of the California Alliance for Elementary Education. In a letter from Delaine Eastin, she recognized the accomplishments, but announced its demise due to the ruling that "the CDE does not have the authority to collect dues or to organize the Elementary Alliance without specific authorization by the Legislature, which it does not have." The August conference was canceled and all activity ceased June 30.
